

**THE VILLAGE BOARD OF THE VILLAGE OF RIDGEWAY, DO ORDAIN AS FOLLOWS:**

**AMENDMENT TO ORDINANCE 4.05 – ALTERNATE SIDE OF STREET PARKING**

**4.05.1 – Alternate Side of Street Parking**

1. Alternate side of the street parking shall be in effect between the hours of 12:01 AM and 4:00 AM, from December 1<sup>st</sup> of each year until April 1<sup>st</sup> of the following year and the temperature is below 34 degrees F. During this time there shall be parking of cars on the Village streets of the Village of Ridgeway only on the even numbered side of each street on the even numbered calendar days on and on the odd numbered side of each street on the odd numbered calendar days.

2. There shall be no parking on either side of any alley in the Village of Ridgeway during the time and during the months that this section is in force.

3. Any motor vehicle which is found parked in violation of this section may be towed away by of at the direction of the Village of Ridgeway Police Department or Street Department at the owner's expense and may be held by the Village of Ridgeway or a private towing service until the fee for such towing has been paid together with the sum of \$1.00 per day as a storage charge. The removal of a vehicle under this provision shall not bar the prosecution of the owners thereof for a violation of this section.

4. No person shall permit a motor vehicle or other item owned by him to be parked or left in violation of the section.

5. Any person, firm or corporation who violates any part of this section shall, on conviction thereof, forfeit a fine of \$25.00, together with the costs of prosecution, but in default of payment of such forfeiture and costs, shall be imprisoned in the county jail until such forfeiture and costs are paid, but no to exceed ten days.

**4.05.2 – Streets with Special Restrictions or Exemptions**

1. All streets within the Village of Ridgeway are subjected to Alternate Side Parking as set forth in section 4.05.1 above unless so stated:

a. Streets with Special Restrictions:

- i. Grove Street: Parking only allowed on West side of street at all times.
- ii. Jarvis Street: Parking only allowed on East side of street in front of the school.
- iii. Weaver Street: No parking allowed on either side of street from Main Street to West Farwell Street. Tow away zone.
- iv. Main Street: Parking only allowed on South side of street from H North to Grove Street.

- v. Alternate side parking from, Grove Street to Weaver Street.
- vi. Parking only allowed on South side of the street from North Street to Level Street.
- vii. Alternate side parking from Level Street to Lorraine Court.

b. Streets Currently Exempt from Alternate Side Parking:

- i. Old Main East
- ii. Old Main West
- iii. Meudt Court

2. Any motor vehicle which is found parked in violation of this section may be towed away by or at the direction of the Village of Ridgeway Police Department or Public Works Director at the owner's expense and may be held by the Village of Ridgeway or a private towing service until the fee for such towing has been paid together with the sum of \$1.00 per day as a storage charge, or actual cost if higher. The removal of a vehicle under this provision shall not bar the prosecution of the owner thereof for a violation of this section.

3. Any person, firm or corporation who violates any part of this section shall, on conviction thereof, forfeit a fine of not less than \$10.00 and not more than \$50.00, together with the cost of prosecution.

THESE ORDINANCES SHALL TAKE EFFECT UPON PASSAGE AND POSTING AS REQUIRED BY LAW.
